Types of Activities to achieve	1. Contact families through reminder/recall cards/text messaging
Target	 Increase community visibility of immunizations (local sport programs, local theater, newspaper articles, newspaper stuffers, website, social media, and radio ads.) Visit or send out parent information to licensed daycares and educate on the importance of immunizations
	4. Evaluate referral patterns for non-immunizing Private Providers who provide health care to children and suggest that appointment be scheduled with their immunization provider while the child is in the Private Provider's office, encourage physicians to refer clients for walk in immunizations.
	5. Evaluate immunization status of all children receiving WIC and immunize as they present for WIC appointments.
	6. Educate clients in all Health Department Programs regarding the importance of immunizations.
	7. Submit educational articles to local newspapers to print explaining the importance of immunizations and dispelling myths which may be a barrier.
	8. Find opportunities to provide immunizations on a variety of days and locations.
	9. Identify barriers to immunizations and try to reduce (Notarized Medical Power of Attorney form/policy, locations of clinics, days of clinics, etc.)
	10. Conduct immunization clinics at HCHD utilizing various clinic hours.
	11. Work with Area Physicians to provide immunizations (VFC, etc)
	12. Environmental Health Division to provide immunization information to their clients as appropriate (i.e. importance of vaccinations to food handlers)
